NOTIFICATION

As directed by the Hon'ble Chairman, it is hereby informed that in view of the existing impediments in conducting the hearing in the Benches of the Tribunal, the Hon'ble Members may conduct the hearing through Video Conferencing from the places at which they are now stationed. As of now, it is not necessary that the Hon'ble Members are physically present in the places where the Benches of Tribunals are located. The Registry shall also process their pay bills as though they are regularly performing their duties. However, they shall be available for Video Conferencing during office hours on working days.

As regards the Hon'ble Members who are transferred recently to various places, the option is available to remain at the places where they are now stationed but to discharge the functions of the Benches to which they are transferred. If there exists any problem as to joining duties, the same can be brought to the notice of the Principal Bench so that necessary arrangements are made in this behalf.

The Registrars of the concerned Benches shall take instructions from the Hon'ble HOD/Members through phone or other electronic device. They shall also facilitate the filing of the OAs through email and the hearing thereof through Video Conferencing without insisting on any technicalities. The Registrars shall submit weekly report to the Principal Bench about the cases dealt with through Video Conferencing or otherwise in their respective Benches.
